

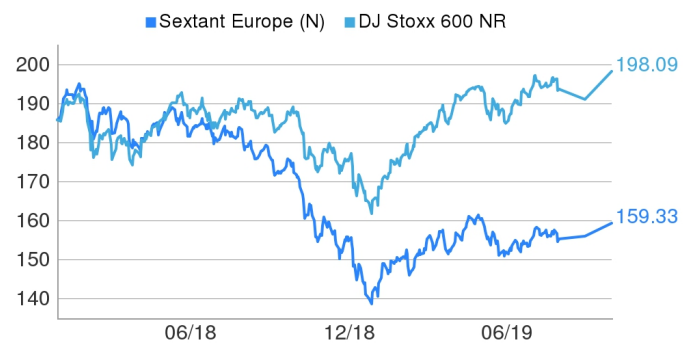
SEXTANT EUROPE



Sextant Europe is a fund that invests in shares of large-cap European companies. It is constructed independently of any reference index, based on a selection of companies with a market capitalization strictly above 500 million Euros. It is eligible for the French Equity Savings Plan (Plan d'Épargne Actions, PEA) with at least 75% invested in European Union and European Economic Area equities.

Stock focus

We acquired a new position in **Dalata** in September. The company is Ireland's leading hotels group, with 25% of available rooms in Dublin. **Dalata** operates in the three-stars category (via the Clayton brand) and in the four-stars segment (Maldron). High cash generation in Ireland allows the company to invest in hotel openings in the UK, a market that currently accounts for about 20% of sales with 10 hotels

(versus 29 in Ireland) at end 2018. **Dalata** has a large property portfolio, mainly in Ireland, that is valued at €1 billion net of debt. We estimate that we acquired the stock at a near-20% discount to its property holdings and a PE 2019e of 11x.

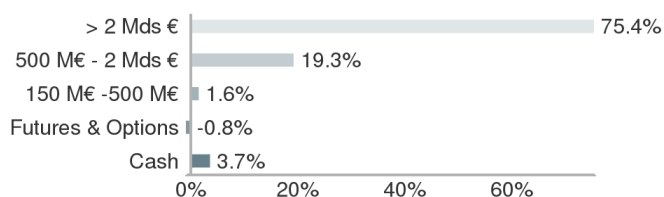

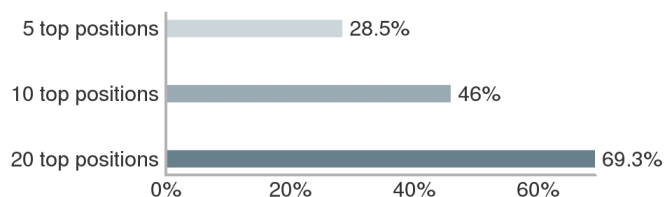

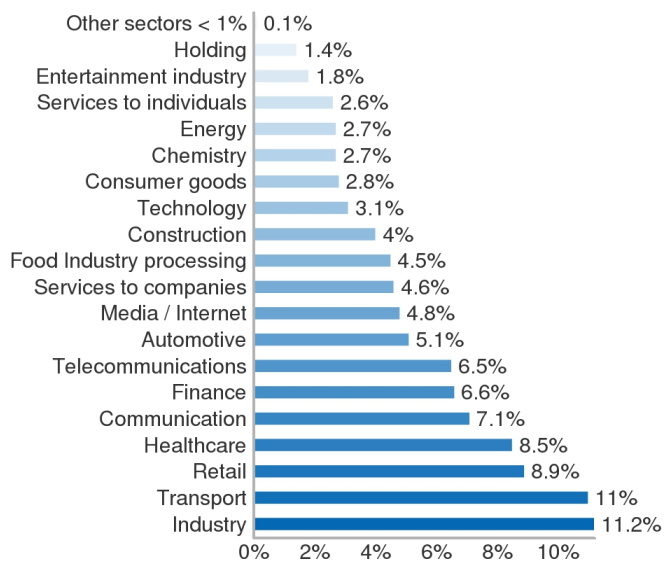
Distribution by capitalisation size



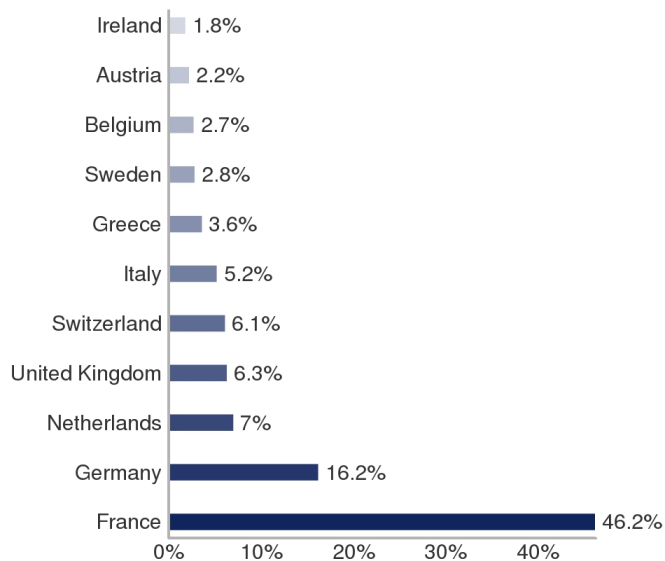
Weight of the main holdings
